

TIPIC Study Group VI January – February 2017



- Are you aspiring to become a Title Insurance Producer Independent Contractor/NSA and would like in-depth training on title insurance concepts in addition to your preferred provider training?
- Are you having difficulty passing the PSI exam?
- Do you want in-depth training and preparation on title concepts before taking the PSI exam?

The TIPIC Study Group assists aspiring TIPICs in understanding title insurance concepts in preparation for passing the title insurance pre-licensing exam offered by licensed providers (approved companies offering pre-licensing classes). In addition to focusing on title insurance concepts, diverse study techniques are discussed, additional resources for in-depth study are shared, lessons learned from students who passed the exam, and more are reviewed in the Study Group class.

Selecting and registering with a pre-licensing provider is a prerequisite for the Study Group class. Students who have already selected a pre-licensing provider must show proof of purchase. Students who have not already registered with a preferred pre-licensing provider can register after a consultation with Elaine Wright Harris.

First, you must determine if you are eligible for the TIPIC Study Group VII. To apply and reserve your seat, fill out the registration form [per instructions] on the next page. Registration must be completed by December 30, 2016.
